I. CALL TO ORDER

- Board President Page called the meeting to order at 6:34 p.m.

• San Juan Water District General Manager Paul Helliker stated he had two items to discuss. He inquired if FOWD received the letter from San Juan Water District Board President Ted Costa regarding discussions with Sacramento Suburban Water District about the merger. He stated that he transmitted the information from the collaboration integration project that SJWD has been working on with six other agencies to General Manager Gray. They have completed the baseline assessment and are now looking at

specific topics by looking at ways to collaborate, improve operations and save money for customers. He invited FOWD to join in the discussion and hopes that FOWD can do some joint activities based on the seven topics.

1. Update and discussion on FOWD Water Supply for the month of September 2020

• Operations Manager Nisenboym reported that during the month of September the average temperature was 2.5° higher than normal with no precipitation. The total system demand for the month was recorded at 1,454 AC-FT. Wholesale connections provided 1,100 AC-FT and groundwater sources provided 354 AC-FT. All surface water was provided by the CTP connection. FOWD participated in a water transfer of 239 AC-FT, transferred to Carmichael Water District via the wholesale connection on Winding Way.

2. Update and discussion on FOWD Groundwater Wells Projects

• General Manager Gray provided an update on the FOWD Groundwater Wells Projects. Test pumping at the Skyway Well will take place on October 12, 2020. The New York Well site will start drilling when the Skyway Well is close to being completed. Staff is proposing Friday October 16, 2020 for the Board to visit the well site.

The Board directed the staff to schedule a site visit to the New York Well location on October 16, 2020 at 3 p.m.
